**Full time** is 32 hours per week or more

**Part time** is between 20 and 32 hours per week.

**Drop in** is anything less than 20 hours a week \*based on availability

**Contracted Scheduled Hours (CSH)** - Hours scheduled each week.

**Overtime (OT)** - Any hours used outside your contracted scheduled hours will be charged an overtime (OT) rate which is the part time rate for your child's age group.

**Status Changes:** You will only be allowed to change your rate status two times in a calendar year.

You must fill out a Status Change Form at least 2 weeks prior to this change.

★ **Discounts & Fees:**

- Minimum charges:
  - Children aged 2-Preschool have a **20-hour minimum charge** per week.
  - Infants & Toddlers (0-2) have a **32-hour minimum charge** per week.
  - School agers will have a **7-hour minimum charge** for before and after school during the school year.  
School agers will have a **20-hour minimum charge** during the summer months.
- Upon registration, a one-time non-refundable \$150.00 deposit is required to guarantee your spot at Hills & Dales Childcare. When a two-week notice is given, the deposit will go toward your final payment(s) in childcare. No cash refunds will be given.
- There is a \$10.00 per family sunscreen charge that will be applied to your bill each April or upon enrollment in the summer months.
- A late fee of \$1.00 per minute per child will be applied to children in the building before or after operational hours (5:30am-6:00pm).
- A 5% discount will be applied for families of 2 or more, enrolled as full time or part time status.
- There will be a \$25.00 fee for all insufficient funds.
- Before and after school transportation fee of \$2.50 per ride.
- Any account not paid in full by Monday will receive a \$10.00 late payment fee.
- A \$5.00 late schedule fee will be applied for any schedule turned in after noon on Wednesday.
